## 3. BUDGET AND LEGISLATIVE UPDATE

Janie Whiteford announced that Karen Keeslar has been named the new CAPA Executive Director and Lobbyist. Congratulations Karen!

Karen Keeslar reported that neither house has taken any action on the best case scenario budget proposed by the Governor which eliminated 80% of IHSS cases and reduction of wages to minimum wage. Now the budget committees are looking at trigger proposal which is a complete

elimination of the IHSS program. The IHSS Coalition has submitted a letter to the sub-committee strongly opposing elimination of the program. The next hearing is the assembly budget sub-committee on May 5 at 1:30, room TBD. Some are hoping that the improvement in the economy will see some of the current deficit come down. We will still be facing battles regarding IHSS and keeping the program.

Janie Whiteford added that the senate sub-committee 3 is scheduled immediately following the meeting on the senate floor around 9:30 or 10:00AM in room 4203 of the Capitol. #### **4. UPDATE ON IHSS LAWSUITS**

Janie Whiteford reported that she would recommend that consumers call their legislators and let them know that they are concerned that there are no consumers in the stakeholders group formed by the administration. All of the work is being done by government workers with no consumer or provider involvement.

Karen Keeslar provided an update on provider enrollment. She said that one of the most shocking things is the requirement that consumers be fingerprinted. The state has indicated that they intend to pilot fingerprinting for consumers in San Diego and Sacramento including fingerprinting and photographing of consumers. They have no legal authority to do this. Even so, they are moving forward. The IHSS Coalition issued a press release today with a hope to get a story in the Los Angeles Times about the state spending \$11 million to implement this action.

An update on IHSS litigation will be coming out soon.

#### **5. DEBRIEF ON CDSS TELECONFERENCE**

Cindy Calderon gave a debrief on the CDSS fraud teleconference. The most prevalent comment was to ask why IHSS recipients and care providers are being excluded from the workgroup being set up. The answer was that this is just a process, more workgroups are coming, etc. Right now, the people involved in the main workgroup are district attorneys, fraud investigators, and some public authorities. A fall workgroup is to start on the P.O. Box process which says you can't have a P.O. Box as a mailing address. The fingerprinting process is also getting a workgroup assigned. The overall perception of the state process is that they are not listening to consumer or provider concerns or input. More stakeholder sessions will be held in June and July. 3PM. The theme of this year's DCAD is the 20<sup>th</sup> Anniversary of the ADA. AB1682 funds can be used for this because it is a training opportunity for Advisory Committee members. You can stay over and then participate in DCAD.

**7. NEXT CICA STATEWIDE CONFERENCE AND PLANNING COMMITTEE**

Melissa Kinley is CICA's conference committee leader this year. The conference will be held October 22-24, 2010 at the San Jose Doubletree Hotel. Janie Whiteford asked for volunteers to participate in the committee. Jane Kardas of Mendocino County volunteered to be on the committee.

**8. REGIONAL MEETINGS**

Planning for CICA regional meetings is in process. The northern region is targeting August for their regional meeting. Ethel Webb stated that the focus for the northern regional meeting will be on fraud from a more positive perspective. Ellen Rollins said that the Central Region is working on a venue for their meeting.

**9. NAPA COMMUNITY FORUM**

Penelope Beasley reported that Napa County is holding a community forum with a focus on advocacy and empowerment. Janie Whiteford will be a speaker.

**10. COUNTY HAPPENINGS**

The Solano County IHSS Advisory Committee will be presenting their 2008-2009 Annual Report to the Board of Supervisors on April 6, 2010 at 8:00AM.
